The annexed song was composed under the following circumstances—

A gentleman had left Baltimore, in a flag of truce for the purpose of getting released from the British fleet, a friend of his who had been captured at Marlborough.-He went as far as the mouth of the Patuxent, and was not permitted to return lest the intended attack on Baltimore should be disclosed. He was therefore brought up the Bay to the mouth of Patapaco, were the flag vessel was kept under the guns of a frigate, and he was compelled to witness the bombardment of Fort McHenry, which the Admiral had boasted that he would carry in a few hours and that the city must fall. He watched the flag at the Fort through the whole day with an anxiety that can be better felt than described, until the night prevented him from seeing it. In the night he watched the Bomb Shells, and at early dawn his eye was again greeted by the proudly waving flag of his country.

The minutes from the Special Meeting were reviewed. Don made a motion to approve the minutes. Adam seconded. All approved.

Donna presented the monthly financial report.

Patti made a motion to approve the treasurer's report as printed. Brad seconded. All approved.

Mandy presented updates on developing the website. Don made a motion to purchase the website name and hosting of an e-commerce website from Wix.com for one year. Adam seconded. All approved.

Jeff Crist visited with the council and shared information about the Marysville Community Foundation.

Mandy talked about the Sacred Art Series. Sterling Oliver will join us in July.

The decision on the land sale was discussed. Brad visited with a lawyer and Patti spoke to an accountant about the question of capital gain taxes. Randy presented a bid from Brian Nichols "Handyman Service" for replacing the wood shingles on the gazebo. The bid was for a total of \$2705.93 which includes material & labor. Patti made a motion to accept the bid. Don seconded. All approved.

Patti is getting bids on painting the parsonage.

Patti shared information about the Eclipse weekend on August 20 & 21. The council was in favor of hosting an ice cream social on Sunday, August 20th. More information to follow.

Mandy and Pastor Julie discussed plans for the "Study at the Spring" on August 5th. They are working hard on the day's itinerary and will be recruiting needed help soon.

The "Spend the Day with Dad" free swim at the Marysville Pool was discussed. The council decided to fund this outreach with funds from the Youth Group Bank Account. This account contains money the church receives from a grant given yearly by the Leo Ring Trust. It is to be used for youth activities. In order to be eligible each year the money must be spent and activities reported to the trustee.

Julie shared that there is trouble with the copier. The repairman was here and fixed the copier. He said the copier was purchased in 2008 and was not sure how much longer the parts will be available to order for repairs.

The next meeting of the council will take place on July 20^{th} at 6:30 p.m.

Evangelical United Church of Christ Special Meeting June 11, 2017

The congregation met in the church fellowship hall for a meeting on determining whether to sell or keep the 40 acre plot of land in Washington County.

Vice President Don Richardson called the meeting to order at 11:15 a.m.

Pastor Julie led the group in prayer. A total of 42 people were present.

Jacque Griswold made a motion to open the floor for discussion on the land sale. Adam Yungeberg seconded.

Discussion was heard from several people about the increase of the land value as the dollar amount decreased.

The question was raised about what the profit from the sale of the land would be used for. Suggestions were heard for investing an amount in money markets, using some for property upkeep, mission, and balancing the monthly budget.

It was estimated that we now make around 2% yearly on the value of the land and could possibly make more through investments.

The question was raised about whether we would be paying capital gain on the income. After making several phone calls that question could not be answered fully.

Jacque Griswold made a motion to table the discussion and have a second meeting within 30 days. Maybelle Circle seconded the motion.

The council will get legal advise on the sale of the land and an answer to the tax question. Council will also look into investment opportunities.

Karen Johnson made a motion to adjourn the meeting. JoAnn Walcott seconded. All approved.
